#### Member at Large

I hope all of you are enjoying your well-deserved summer break. The Quality Assurance Committee has begun the process of reviewing members' Continuing Competency Logs. It was awesome to see that the majority of members exceeded the 25 hours of professional development. Those members will receive notification that they are considered a *Member in Good Standing* with respect to Section 2.3 of BCASP Bylaws and Constitution (2018).

2.3 All members must actively participate and engage in activities which maintain, expand and update their professional skills. This requirement is met by completing at least 25 hours of professional development each year to promote a high practice standards among members. The Quality Assurance Committee (or Executive Committee) may monitor compliance with continuing competency requirements or other requirements of BCASP's quality assurance program by conducting random audits of members by mail or by using another method approved by the board.

There are some members who are short the 25 hours of professional development for 2021. If you fall into this category, at this time you are <u>not</u> a *Member in Good Standing* with respect to Section 2.3 of BCASP Bylaws and Constitution (2018). To regain your status as a *Member in Good Standing* as per Section 3.3.2 (d) of BCASP Bylaws and Constitution (2018)), you will have until December 31, 2022, to complete these hours. Please note that this is in addition to the hours you must complete for 2022.

- 3.3.2 All members are in good standing except:
- (a) one who has failed to pay current annual membership fee or any other subscription or debt due and owing to the society
- (b) one who is in breach of Standard 2.2
- (c) one who has had an ethical complaint whose resolution was determined that the member is not in keeping of BCASP standards, and therefore not a member in good standing.
- (d) one who is in breach of Standard 2.3

There are a handful of members who have not yet submitted their Continuing Competency Log and therefore are <u>not</u> a *Member in Good Standing*. To regain your status as a *Member in Good Standing* as per Section 3.3.2 (d) of BCASP Bylaws and Constitution (2018), you will have until December 31, 2022, to complete these hours and submit your Continuing Competency Log. Please note that this is in addition to the hours you must complete for 2022.

It is important that all members maintain the standards that BCASP has for Continuing Competency. This is particularly significant as we prepare for our eventual move to the College of Psychologists. As discussed at the AGM with **Dr. Andrea M. Kowaz, Registrar of the College of Psychologists of British**Columbia, current BCASP *Members in Good Standing* will be ported over to the College as a group without further scrutiny. As well, those who are not a *Member in Good Standing* will cease to be a member of BCASP after a period of 6 consecutive months as per Section 3.3.1 (d) of BCASP Bylaws and Constitution (2018). We have extended this grace period to December 31, 2022.

- 3.3.1 A person shall cease to be a member:
- (a) by delivering his resignation in writing or email to the Secretary-Treasurer of the society or by mailing or delivering it to the address of the society.
- (b) on death.
- (c) on being expelled.
- (d) on having been a member not in good standing for 6 consecutive months unless written application for deferral or moderation of fees, due to extenuating circumstances, has been approved by the Executive.

Please note that for 2022 and going forward, minimum hours must be completed in each category.

Category A: Formal Conference, Courses or Workshops – 9 hours

Category B: Self Study – 8 hours

Category C: Structured Interactive Activities

Category D: Ethic – 5 hours (These are not additional hours, but hours included in

Category A, B, or C that focused explicitly on ethics.)

# 7th Annual Spring Workshop 2022

Thank you ALL for attending our 7<sup>th</sup> Annual Spring Workshop this year. As always, it was an absolute pleasure to learn and grow with each of you. This year, Dr. Donna Henderson provided us with an excellent presentation on the less obvious presentations of Autism. I especially enjoyed her down-to earth and interactive presentation style. In my opinion, this approach created an engaging and optimal opportunity for us to deeply conceptualize the complex nuances of Autism.

With regards to our survey, we want to extend a special thanks to those who took the time to respond. We are especially grateful for your thoughtful feedback and appreciation. Furthermore, your insights gave us a much-needed breath of fresh air, to help remind us why we do the work we do, in putting these events together. On more than one occasion, I found myself reading, and re-reading your comments for inspiration, and even just for fun. Thank you!

This year 64 people responded to our survey. Of those who responded, 100% of you found that the quality of Dr. Henderson's presentation and the overall quality of the workshop, was of good or excellent quality. 93.5% felt that the webcast experience was good or excellent, while 5.4% found it to be fair to satisfactory.

With our new 'Easy Reg' registration process, we were particularly curious to see how you would rate the ease of registration. We are happy to report that 96.8% said that your ease of registration was good or excellent, while 3.2% found the registration process to be satisfactory.
